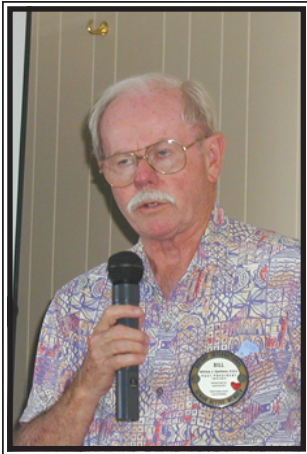




Meeting June 19, 2008

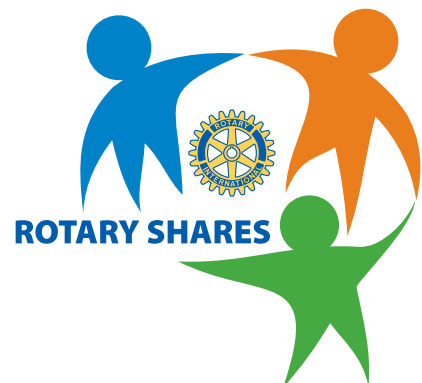
