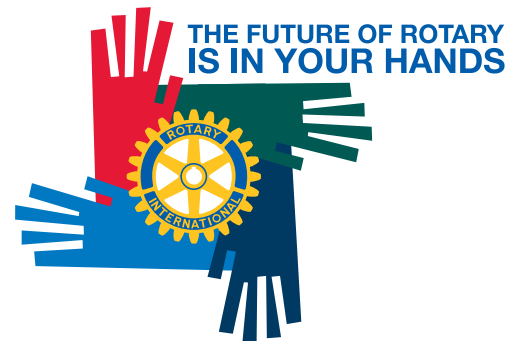

older projects as well as some new projects we have going on.

Jeff Hata announced that our Casino Night is coming along. So far we have budgeted expenses of \$7,000 and we have sponsorship commitments of \$5,000. With the tickets out we should cover our expenses. Thank you to everyone who has stepped up and bought a sponsorship, is selling tickets or will be donating an auction item. Your efforts are appreciated. We still need more auction and raffle items though!

Deborah Perkins led our Rotary Recognition session with the topic of the Breeze. Based on the answers it appears more people need to read the Breeze.

Deborah Perkins then held our raffle drawing which was won by Steve Phillips

Rocky Ludes then introduced our speakers.

Today's program was from Habitat for Humanity. Board President Scott Swanson and Secretary Nancy Staley – both Rotarians – showed slides and spoke about Habitat. The organization was founded in 1976. The Ventura affiliate, the first in the State, was created in 1983. Habitat is working to eliminate poverty housing in the County.

Habitat works with a variety of volunteers and organizations. The homes built by Habitat are sold without profit to low income families after quite a screening process. However, families are selected according to the Federal Fair Housing Laws. Habitat acts as the "bank" but charges no interest to the families. The monthly payments include an impound amount for property taxes and homeowner's insurance and usually range from \$450 to \$650 per month. Many families pay their monthly payments in person. The family income must be between 30-50% of the median income in the county, which is \$70,000 per year. Therefore, qualifying family income would range between \$21,000 and \$35,000 per year. Each family chosen to receive a home must provide 500 hours of "sweat equity."

In Ventura County, Habitat has built almost 50 homes and rehabilitated or repaired about 500. From their general contributions, they have also helped build 100 homes in Malawi, Africa. Land is often acquired from local cities at no cost, allowing the home to be built and sold far below market. However, permits and fees can add significant costs to the home.

Scott and Nancy showed pictures and commented about Habitat homes built in the county. Because recipients purchase their home, there is a distinct pride of ownership that often is missing among

some who rent. Habitat prohibits families from renting any part of their home, and maintains a first right to purchase if the family wishes to sell.

Habitat also operates ReStore, a unique thrift store. Located north of Oxnard on Vineyard, this store has materials and fixtures that could be used in another home, such as cabinets, plumbing fixtures, lighting fixtures, major kitchen appliances, windows, air conditioning units, ceramic tile and much more, all available for sale to anyone wanting to do some remodeling or repairing.

Each home is built with volunteer labor supervised by two full-time employees. Working on a home builds a lot of teamwork, and some companies have used this as a teambuilding exercise. from the chest down following a 2005 vehicle accident, but continues to work for the police department in the dispatch center.

"The whole point [of the GSE] was to dissolve the perception of people in wheelchairs," Martin explains. "Just because we're in wheelchairs doesn't mean that we can't do things that able-bodied people can do."

The idea for an all-wheelchair GSE started two years ago when Charlie Tegarden, 2008-09 governor of District 5490, struck up a conversation with Darol Kubacz in an airport. The two were returning from Mexico where they had helped distribute wheelchairs to the needy as part of a Rotary project. Kubacz, a wheelchair user, was curious to learn more about Rotary, and Tegarden was happy to oblige.

Eventually, the conversation turned to Group Study Exchange," Tegarden recalls. "As I was talking about how great GSE was, I was thinking to myself that it was too bad that a person like [Kubacz] could not participate. How could he possibly travel? ... Then the obvious struck me -- he was sitting right there with me in the Mexico City airport! Why couldn't he participate in a GSE?"

Determined to host an all-wheelchair GSE, Tegarden found a partner in Tony Castley, 2008-09 governor of District 9680, whom he met at the 2007 RI Convention in Salt Lake City, Utah. Past district governors Harold Sharp (9680) and Don Schiller (5490) coordinated the exchange, and the idea became reality. Kubacz, now a member of the Rotary Club of Phoenix-West, served as the Arizona team leader.

Some Rotarians were initially a little uneasy about an all-wheelchair GSE because of a perception that disabled people "are either subnormal or unable to live and travel independently and hold down full-time, worthwhile employment," says Sharp, a member of the Rotary Club of Crows Nest, New South Wales, and the GSE's cochair. "As a result of the exchange, the attitude in our district has totally changed."

Sharp, who is retired from a career in nonprofit management, counts himself in that group. "Though I have for many years been involved with people with disabilities, the wheelchair GSE allowed me to become very involved on a day-to-day basis. It was only then that I realized that I was totally underestimating [disabled people's] abilities and desire to be judged on their results and not their appearances."

In Arizona, "we've opened the door now to people with disabilities," says Schiller, a member of the Rotary Club of Prescott-Sunup and the district's GSE chair. "We might not do another all-wheelchair GSE, but I can see disabled people participating in our next GSE, just like anyone else."

As for Martin, he's considering joining the Prescott-Sunup club.

"As a police officer, I was able to serve the community, and that was very fulfilling to me," Martin says. "Now, I have found a way to fill that void and still get out there and help the community.

"I'd like to be a team leader in a future GSE."

Steve Phillips was our lucky winner! Congratulations Steve.





# Scholarship in Israel pays tribute to prominent Rotarian

Each year, the Moshe Greidinger District Scholarship Fund invites Rotary clubs and districts worldwide to propose candidates for a year of postgraduate study in Israel.

The fund, administered by District 2490, was established by Rotarian Kenny Greidinger in 1967 as a tribute to his father, whose Rotary connections played a critical role in the family's safety during World War II.

Greidinger was 17 years old when his family embarked on a grueling 17-day boat ride to Durban, South Africa, in 1941. The British government had just issued an emergency evacuation of its citizens from Palestine, and Greidinger's family, who had immigrated there from the United Kingdom in the early 1930s, was among the evacuees.

After arriving in South Africa, however, the family was denied entry because Greidinger's niece and nephew had been born in Palestine and therefore were not British citizens. Facing an exhausting and dangerous return trip through submarine-infested waters, Greidinger's father, Moshe, requested a meeting with the director of immigration.

Moshe, a charter member of the Rotary Club of Jaffa-Tel Aviv, Palestine, was wearing his Rotary pin that day, which was noticed by the immigration director, who sported one on his own jacket. The two men formed an instant bond, Greidinger recalls, and the director allowed the boat to come ashore. He later helped the two children obtain British citizenship.

"I was so impressed by the influence Rotary carries internationally," says Greidinger, a member of the Rotary Club of Haifa, Israel, since 1951. "We were incredibly relieved to find out the immigration director was a Rotarian. Without the Rotary tie, we would have had to go back."


Greidinger says his father, a prominent businessman, consistently devoted his time and energy to public service and charity.

"He was truly a Rotarian by nature, with a deep conviction of Service Above Self," he says.

Greidinger served as district governor in 1966-67, when he set up the scholarship fund, which covers tuition, board, and lodging while recipients study in Israel. Students may choose from a wide selection of universities and institutes, in fields including agriculture, history, medicine, music, industrial engineering, and international relations.


The ultimate goal of the scholarship, says Greidinger, is to give the winners the tools to enrich themselves academically while introducing them to Israeli culture.
