Tom Swan spoke about the upcoming Membership and P.R. Seminar in Santa Barbara on Aug. 28 or Aug. 21 in Bakersfield.

Carol Marquez Olson spoke about the importance of reporting your makeups in a timely manner.

Jeff Hata continued to give out awards from last year ... Rocky Ludes received a plaque in recognition of his outstanding work as our program chair and Michelle Mercado received a Paul Harris Award.

Terry McBreen then conducted our raffle and the lucky winner was our speaker Michael Ellingson.

John Masterson then introduced our speaker.

Today we heard an update on the construction plans for Community Memorial Hospital. CMH is now part of the Community Memorial Health System which now includes the Ojai Valley Community Hospital. Michael Ellingson, VP of Marketing & Development, gave the excellent presentation.

There is a two-fold need for rebuilding this hospital. First, the State of California has a required seismic retrofit, the result of the Northridge and other earthquakes. Second, the existing hospital was built over 50 years ago and is simply outdated in several respects.

The new hospital will be 6 stories and include 330,000 square feet, with 252 private rooms. There will be additional privacy for patients in all areas, including elevators, some hallways, and in the emergency department. The latter will be enlarged and will include imaging capabilities. The obstetric and pediatric units will be expanded, as will the critical care facilities. The existing 7 surgical theaters will be expanded to 10, but these will be larger, and each will be capable to be used

for modern day surgeries, including joint replacement and open heart surgeries. The existing hospital building will not be torn down, but remain for other purposes. Certain administrative work has been moved away from the hospital facilities to Olivas Park Drive to alleviate congestion.

Diagrams and computer graphic imaging were projected to give us a feel how the new facility will look from all angles. A diagram of the existing property was shown, highlighting the expanded footprint with the surrounding properties that have been acquired. The new main building will have its entrance off of Main Street.

Financing for this project may cost \$320 million, with about \$25 million in donations, \$45 million from hospital reserves, and \$250 million in new loans. At this time, over \$5 million in donations have been received or pledged. The loans should be secured within the next few months.

Construction is well underway for the new cancer center which will then house the radiation oncology section currently on Cabrillo Dr. This center will have its opening later this year. The general groundbreaking for the hospital itself will be next spring. In the meantime, Ojai Valley Community Hospital has been updated with a new six-room emergency department.

Thank you, Michael, for your update and for answering all our questions.

THE ROTARY CLUB OF VENTURA-EAST VISITS USS MOBILE BAY CG53

The Rotary Club of Ventura-East (RCVE) Invited to Observe Combat System Ships Qualification Trials (CSSQT) Aboard Naval Warship

15 July 2010, at approximately 0600, Rotary Club of Ventura-East (RCVE) members Wendy Pazen, President; Jeff Hata, Immediate Past President; Deborah Pudlewski-Roberts, Past President; and Robert Pazen O.D., Past President became guests of Captain James J. Housinger aboard Naval Warship USS Mobile Bay CG 53.

RCVE members flew from Brown Airfield in San Diego via helicopter to the Ship some 50 nautical miles out to sea where they were greeted on the flight deck by Senior Officers of the Ship and Naval Sea Systems Command (NAVSEA) Engineering staff. After being shown to their respective racks and an initial meeting with the Captain, RCVE members were given an in-depth tour of the ship before being taken to the Combat Information Center for a comprehensive briefing on information processing and weapons deployment. A trip to the Bridge followed to observe the first daily CSSQT exercise: target practice with the 5"/54 caliber Mark 45 guns. Later, lunch was held in the Ward Room and discussions with Ship's Officers ensued.

Over the course of two full days and one overnight, RCVE members were able to witness additional exercises such as the Phalanx close-in defense system engaged in target practice, as well as its tracking abilities; and the 5"/54 caliber Mark 45 gun successfully destroying targets trailing behind a sub-sonic leet jet flying within the Ship's target area.

RCVE members were granted access to all ship personnel, freely toured the ship and were allowed to snap personal photographs.

"The CSSQT testing was absolutely amazing! I had no idea our Naval Ships were so prepared for anything that might come their way. It was like being in a movie! And there was always so much going on around the ship, beyond the CSSQT testing, we began to wonder what surprise we might find around each corner or corridor as we navigated our way around the Ship. During a lunch break we even found ourselves witnessing and getting a lesson from Captain Housinger on the process and procedure for drug testing; the same for him as for his crew. The entire two days, from helicopter takeoff on Thursday morning to landing back in San Diego on Friday evening, were truly incredible!" – Wendy Pazen, RCVE President

"I wish I could narrow it down to just one favorite thing. Truth be told, 300 plus sailors, all an average age of mid 20's, were better trained, more knowledgeable and certainly more confident in their abilities than I could have ever imagined. They took their time, calculated each move and worked together so well that, if there were any testing failures, they weren't apparent to us! The ability of the crew, combined with the weapons systems capabilities were mind-blowing! It talks to the Captain's ability to instill that kind of confidence in so many men and women. Then there was the food; I could live like that! Not only was it delicious, but the fact that the staff took so much pride in their ability to 'motivate' the crew with their creations was


