Presidents Message ...

Lets see.... Where was I? Oh, I know... Friday night Sept 30 was crazy at Moorpark. The trailer worked out well, although the poor old barbecue unit that we have been using for the past several years is on its last leg. Auggie and Jordan ran out of time before they could complete construction of the new barbecue units, so we pressed the old barbecue into service for this weekend, and we were operating at 125% of capacity; using double layers of

food, butterflying the tri-tips to make them cook faster and slicing off corners of the tri-tips to serve while the centers continued to cook. Crazy, that what it was. Just plain crazy, and we enjoyed every minute.

We closed up, cleaned up and left Moorpark at 10:30PM Friday night. At 8:00am the next day we dropped off the trailer at the Camarillo Air Museum for the second leg of this maiden voyage for the new trailer. Jeff Hata and I figured out how not to set up the screened enclosure and made triple sure that we had it right. This enclosure is a sweet deal. Jordan commissioned a canvas maker to design and create it. Auggie and Jordan permanently installed an "RV type" awning to the trailer, then had the canvas maker create an enclosure to wrap around the exterior of the awning posts. It snaps into place on both ends, and fits into a channel cut into the front top of the awning. With two rollup windows and an exterior plastic pocket for menus, this will be a great asset should we pursue cooking in street fairs.

The trailer also has a 3-compartment sink and separate hand washing sink attached to an on-demand "flash" water heater. Three 50-gallon water tanks are permanently mounted to the underside of the trailer, one for fresh water and two for grey water per health code requirements are plumbed to both sinks. The grey water tanks have RV-style dumping valves. Also we have installed a stainless steel work table, a freezer, a marine inverter with three marine batteries to give us internal power, along with all the electrical panels, pumps and switches to make it easy to use. Add lights inside and out, aluminum shelving, a side door accessing the screened enclosure, and a ramp at the rear of the trailer, also screened and you have a vague picture of how the trailer can function for us.

We could not have succeeded with this endeavor without the help of Bill Spellman, Carol Marquez-Olson and new member Katrina Dangleman making chicken kabobs in the trailer all day long. Jeff Hata, Jordan Eller, Deborah Roberts, Bob Lynn, Rich Stewart, Harriet Clune, John Borneman and Linda O'Neill, Midge Storke, Sam Marsh, Tim Hughes, Joe and Marie Strohman, Vance Thompson, prospective Rotarian Al Jonas, Bill and Mason Grey, Jesse Gonzales, and new Rotarian Rick Shimmel taking turns at

John Masterson introduced our speaker Mike Ellingson from CMH.

Mike Ellingson the Vice President of Marketing and Development for Community Memorial Hospital ("CMH") led a presentation on the status of the hospital remodel and construction. The plan includes modernizing the hospital in Ojai and constructing a new building in Ventura.

The new building is scheduled to open in approximately three and one-half years. The next twelve months will be dedicated to excavating dirt about 60 feet deep and installing approximately 2200 pillars. The second twelve months will focus on erecting the steel frame of the building. The final months will be spent enclosing the structure and outfitting the interior. At this time, engineers are testing pillar strength, and the planners are in the final stages of obtaining the necessary building permits.

The new building will have all private rooms, ten surgical suites, an eight bed pediatric unit, and an expanded emergency room and intensive care unit. In addition, CMH is proudly opening a wound center which will feature a hyperbaric chamber.

Mary Schmitz, the Director of Development, discussed the hospital's campaign to raise \$25 million for this project. Currently, the focus is on an internal campaign in which the hospital looks to its doctors, staff, and supporters for donations. Thereafter, the focus will shift to a public campaign. \$6.5 million has already been raised.

We were treated to a viewing of the hospital's promotional video which focused on how CMH has touched the lives of those in our community. We heard Tami's story of being treated for breast cancer, Dave's story of being treated for chest pains, and Will's story of having back surgery. All three were quite impressed with the hospital staff and eternally grateful for the care they received.

Thank you CMH for the way you care for our community.

Rotarian circles Australia in a dinghy for polio eradication

Many Rotarians have gone to extremes to raise money for Rotary's US\$200 Million Challenge.

But Australian Rotarian Robert Pennicott set a record with his fundraising venture. Pennicott, fellow Tasmanian Mick Souter, and cameraman Zorro Gamarnik became the first people to circumnavigate Australia in boats powered by outboard motors.

Pennicott, a member of the Rotary Club of Kingston, and Souter piloted two 17foot-long inflatable dinghies, twin propelled by horsepower engines, on the 12,000-mile journey around the Australian continent (including the island state of Tasmania). They began in Sydney on 2 June and arrived back on 11 September.

"Rotarians have worked tirelessly toward eradicating polio for the past 25 years. With now just 1 percent to go, I decided to do something different and a bit 'out there' to try to raise a bit of money," Pennicott said. "I believe it's the weird and wacky ideas that get people talking, and I don't think they come much Australia, cont'd on page 6

crazier than traveling around Australia in a rubber dinghy."

The effort, dubbed Follow the Yellow Boat Road, has raised more than \$250,000 to date, and fundraising will continue for several months. Rotary's challenge, which seeks to match \$355 million in grants from the Bill & Melinda Gates Foundation, will receive 92 percent of the proceeds; the remainder will support nature conservation projects through a foundation Pennicott established in May. Trip sponsors included National Geographic Traveler, Tourism Australia, branding firm Green Team, and communications company Telstra.


Pennicott, a tourism entrepreneur who owns Pennicott Wilderness Journeys, began planning the adventure three years ago. He invested over \$100,000 of his own money, which covered the cost of the voyage itself.

The two bright-yellow dinghies, Polio I and Polio II, bore the Rotary emblem on their hulls; it also was emblazoned on the team's jackets and all promotional materials. Gamarnik shot footage of the entire journey, producing videos of each leg of the trip for a blog. Satellite tracking allowed visitors to follow the boats' daily progress.

Along the way, business colleagues, family members, and friends joined the team for legs of the trip. Rotarians from District 9830 (Tasmania) organized much of the land-side support, and Rotarians around the continent hosted the travelers at various ports of call. At each stop, Pennicott spoke to media and the general public about Rotary and polio eradication.

"A large part of this journey has been about raising awareness of Rotary's work with polio eradication," Pennicott said. "As we traveled around Australia, I presented to thousands and thousands of people. With polio no longer in the face of everyday Australians, it's been important to educate the public about the effects of the disease and why we need them to support our efforts to wipe it out completely.

"Ultimately, it's exciting to think that we could see polio wiped from the face of the planet in our lifetime," he added. "Bill Gates wouldn't have pledged \$355 million if he wasn't confident that the disease could be eradicated. We really are just this close."
