Ron Polito gave us a report on the RCVE foundation.

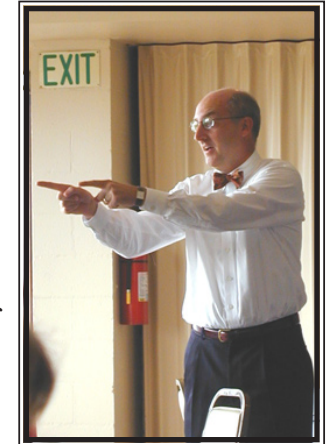

Judge Fred Bysse introduced our speakers.

Our program today was given by Jim Mangis, Executive Director of the Ventura City Corps. The Ventura City Corps began in May 2008 and already has over 35 members. It targets primarily at risk youth between the ages of 12 - 24 years old and teaches them civic responsibility and active citizenship.

The City Corps is guided by their motto "learning through work and service". Projects that you might recognize that they helped with are: the push 'em pull 'em parade, the 4th of July fireworks, Summerfest, Art Walk, restoring the Elks Lodge, and cleaning and watering the plants in downtown Ventura. Up and coming programs that they will volunteer with include: the Kevin Costner Concert, distributing the new Ventura Breeze (not our newsletter!), Music under the Stars, and this Monday they will help with the removal of sand from the steps at Pierpont beach. The Ventura City Corps has been diligent in recruiting partnerships within the city of Ventura. City Corps is currently supported by the Kiwanis club, the Lion Club, Ventura Chamber of Commerce, City of Ventura, Oxnard City Corps and the Ventura Unified School District.

The Ventura City Corps would like to grow its membership to 100 within the next year and is actively seeking donations and board members. They need to raise \$300,000 by next year to fulfill all of their goals!

Hueneme Rotary Club disbands

After 67 years of good fellowship and service to the community, the Port Hueneme Rotary Club has closed its doors.

Down to seven members and no longer able to organize fundraisers on its own, the club met for the last time on June 25 at the Baker's Square restaurant on Channel Islands Boulevard.

"I'm really saddened," said Lennie Confer, 64, who has been president of the club for the past three years.

The club's efforts to replenish its ranks have not been successful, she said.

"It used to be what can I do for you; now it's what can you do for me," she said.

But the moment of bitterness passed quickly as she rattled off some of the Port Hueneme causes the club has helped over the years: after-school programs, scholarships, beach cleanups, garage sales for the Boys & Girls Club.

To do something for others makes her "feel excited," Confer said. "I just feel good."

For Bob Hodge, 83, the club "has been part of my life for 51 years. We've done a lot of wonderful community service projects," he said.

Unlike some other Rotary clubs, the Port Hueneme club kept its fees low — \$12 a month — so anyone could join, said Kent Johnson, who is in his 40s and is the club's youngest member.

To raise money, the Hueneme Rotarians have sold a lot of things, including strawberry beer at the Strawberry Festival and regular beer at the Ventura County Fair. Once there were enough members to sell beer at the fair every day for a week, Hodge said.

Not anymore.

"We've had a strong emphasis on helping schools," said Hodge, who

was an administrator with Hueneme schools for 30 years.

The club started giving outstanding student awards in 1955 and later began to give scholarships to high school students. This year, Hodge dug into his own pocket for an additional \$2,000 scholarship in memory of his wife, Anna Belle, who taught in Hueneme schools for 29 years.

"I'm retired and living on a fixed income, but I saved for it," Hodge said. "I thought it was an important thing to do. ... My wife's philosophy was to do as much as you can to help kids."

Over the years, there's been a "generational change" in the club's membership, Hodge said. "Younger people would come for a year or two and then stop coming. It was not a lifetime commitment like it was for us."

These days people have less time to take part in service club activities, he said. "People are extremely busy, especially if they have families. There are more organized activities."

The club has not limited itself to helping the Port Hueneme community. It sponsored a clinic in Mexico, near Los Mochis. A nurse who belonged to the club would fly down to lend a hand at the clinic once a month, and the club helped raise money for heart operations for Mexican children.

"It's certainly a good feeling to help others that need help," Hodge said. "There's effort involved, but it all comes to a culmination."

By the time the club closes out its books later this year, it will have donated \$39,000 to various causes in 2008, said Jim Daniels, 82. Next year the club's beneficiaries will no longer be receiving support, and that "doesn't feel right," he said.

Daniels said he enjoyed selling beer at the County Fair. Sometimes women customers would come up to the booth and invite club volunteers to come out and dance.

"Last year we sold \$6,000 in one night," he said.

But giving awards to children was his favorite part of Rotary, Daniels said.

"You felt you were contributing to your community and your school. We were very happy and proud to do that."

On June 18, the city of Port Hueneme paid tribute to the club. "We are forever grateful for your service and for your friendship to the city," Mayor Toni Young told a group of club members. "You have been great friends."

Though the club is gone, the spirit of service endures. Hodge and Daniels said they will join the Rotary Sunrise Club in Oxnard, and Johnson said he will do more work with his church.

Confer said she will work with the Navy League, which helps Navy families. "I can't wait for the next project," she said.


